


# **Katherine A. Kendall Institute for International Social Work Education Request for Grant Proposals**





Dear Applicant,

The Katherine A. Kendall Institute for International Social Work Education (KAKI) strives to prepare educators, researchers, students, and practitioners for an increasingly global community through its programs and initiatives. Established in 2004, with contributions to an endowment in honor of the late international social work icon Dr. Katherine A. Kendall, KAKI promotes standards of excellence for international social work to integrate related concepts into social work curricula and seeks to enrich perspectives, understandings, collaboration, and networking within the social work education community.

KAKI is pleased to offer up to five international social work grant opportunities to Council on Social Work Education (CSWE) members at a maximum of \$10,000 for the CSWE fiscal year 2018-2019. KAKI hopes to fund projects that support education in international social work and enhance curriculum building that focuses on international and/or global topics. The projects should help prepare North American students for global citizenship and encourage opportunities for international social work. The grant topics should strengthen what Americans know about the world and should be U.S. based. Projects should demonstrate an impact on student learning. Opportunities can also include work with nongovernmental organizations, the United Nations, or other international entities. Projects must demonstrate impact and transferability to advance the field of international social work education.

- One member of the project team must be a CSWE member throughout the duration of the grant.
- Travel funding should not be the primary purpose of the grant application.
- Annual progress reports will be required; additionally, grantees may be asked to disseminate the results of their work to the appropriate scholarly and public audiences.
- Projects should be completed within 3 years.
- Each project participant must be affiliated with an organization that strengthens social work education. Grants cannot be used to pay overhead costs.

Proposals will be accepted through an online application available at <https://cswe.fluidreview.com/> through April 1, 2018. Applications must not exceed 10 pages. Funds will be disseminated after July 1, 2018. Thank you for your interest in KAKI.

## **Grant Application Contents**

1. Project Abstract
2. Statement of Need

## **Proposal Contents**

### **1. Project Abstract**

The abstract should present a concise summary of the project. It should include the need for the project, the population it will serve, and its goals and objectives, as well as the applicants background and qualifications. The amount of funding that is being sought should be included. Finally, share how the project will be evaluated to measure its success.

### **2. Statement of Need**

The statement of need should describe the problem the project will address. Also, describe the population that will be served. The statement of need should show how the proposed project will advance the state of the art in international education.

### **3. Project Description**

Describe the project and provide information on how it will be implemented. Include descriptions of what will be accomplished and the desired outcome. Be sure to indicate how these will advance education for international social work and benefit other programs.

### **4. Goals and Objectives**

Describe the project objectives as related to specific expected outcomes. Be sure to indicate how these objectives will advance education for international social work and benefit other programs.

### **5. Timeline**

Provide a timeline for the project, including when the project funds will be used.

### **6. Transferability and Dissemination**

Describe plans for how the project's results, findings, and information will further global social work education among U.S. social work programs.

### **7. Budget**

Include in the budget and brief narrative for all anticipated expenses for your project. Provide specifics about how funds will enhance or support your project. Project funds are not to be used primarily to fund faculty or student travel. If travel costs are included, they must be kept to a minimum and narrative must demonstrate a connection to the outcomes proposed. Please mention any funding from other sources or additional anticipated resources needed.
