Over the course of their master's programs, the fellows have focused their academic interests in mental health and/or substance use topics. Fellows have acquired skills that will enable successful social work careers in a range of practice settings through enriching field learning opportunities.

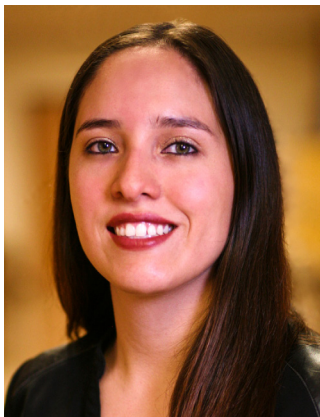
