# 2011 Survey of Social Work Programs: Study Brief

In fall 2011, survey invitations were sent electronically to program directors at all accredited social work programs (685) and doctoral programs that were members of the Group for the Advancement of Doctoral Education (71). Response rates for 2011 were 96.0% (453) of baccalaureate, 97.7% (208) of master's, and 95.8% (68) of doctoral programs. # FACULTY

In 2011, 426 institutions (80.2%), reported a total of 9,825 faculty members— 4,730 full-time and 5,095 part-time.

- 69.0% of full-time and 72.0% of part-time faculty were female
- 28.6% of full-time and 22.5% of part-time faculty were from historically underrepresented groups

### Tenure and Highest Earned Degree

- 46.2% of full-time faculty were tenured
- An additional 23.2% were on tenure track
- Most faculty had an MSW–87.9% of full-time and 89.8% of part-time
- 69.1% of full-time faculty held a doctorate as highest earned degree

# STUDENTS

As of Fall 2011, there were 85,290 full-time and 26,129 part-time social work students.

#### Student Demographics

- Most students were female—87.8% baccalaureate, 85.8% master's, and 77.9% of doctoral students
- Part-time students tended to be older than full-time students at each level
- A higher proportion of part-time students were from historically under-represented groups at baccalaureate and master's levels, but the reverse was true at the doctoral level

#### Student Field Placements

Baccalaureate and master's programs were asked to provide information about the settings of students' field placements. The field settings with the most students are listed below.

#### Baccalaureate

- Child welfare 17.2% (2,570)
- Family services 11.1% (1,667)
- Mental health 10.1% (1,509)
- Aging/Gero 9.1% (1,363)

#### Master's

- Mental health 23.0% (7,196)
- Child welfare 12.3% (3,840)
- School social work 12.0% (3,744)
- Health 11.3% (3,521)

Master's programs were asked to report their concentration offerings and number of students enrolled.

#### Employment—Doctoral Graduates

The Annual Survey also requested information about employment status of the doctoral graduates.

- 31.8% (102) were employed in tenure-line faculty positions
- An additional 12.8% (41) were employed in non-tenure-line faculty positions
- 1.6% (5) were unemployed
- The employment status was unknown for 61 graduates (19.0%)
