<b>June 2019</b>	Joint EPAS 2022 committee meets to review environmental scanning data and develop Draft 1 of educational policy based on data recommendations
<b>Oct 2019-Dec 2019</b>	Draft #1 of proposed changes for EPAS 2022 Educational Policy released for public review, feedback and comment. Feedback sessions at APM.
