Traditional Pathway to Accreditation

Beginning August 2025

Steps:

- 1. Choose the program's target retroactive accreditation date and review the corresponding <u>Timetable for Candidate Programs</u>.
- 2. Submit Candidacy Eligibility Application and fee.
- 3. Submit Benchmark 1 materials to Accreditation Services Manager for staff review.
- 4. Once approved, program is granted pre-candidacy by Accreditation Services Manager, assigned to an Accreditation Specialist, and assigned to BOA agendas for:
 - Benchmark 1 decision
 - Benchmark 2 decision
 - Benchmark 3/Initial Accreditation decision
- 5. Assignment to BOA agenda subject to 10 new programs (baccalaureate, master's, or practice doctorate) per agenda.
- 6. Existing steps are followed regarding submission of program materials and visits.



Timetable to Candidacy

Steps:

- 1. Choose the program's target retroactive accreditation date and review the corresponding <u>Timetables to Candidacy</u>.
 - Timetable to Candidacy Status: Fall 2025 Retroactive Accreditation
 - 3 Submission Options
 - Timetable to Candidacy Status: Fall 2026 Retroactive Accreditation
 - 3 Submission Options
 - Timetable to Candidacy Status: Fall 2027 Retroactive Accreditation
 - 3 Submission Options
 - Timetable to Candidacy Status: Fall 2028 Retroactive Accreditation
 - 1 Submission Option
- 2. Submit Temporary Alternative Pathway Application, complete/finalized self-study for staff review, and fee in per program's planned timetable to candidacy.
- 3. Once approved, the program is granted candidacy and based on the approval date per the timetable, retroactive accreditation is secured (if/when the program is eventually granted initial accreditation)

Timetables to Initial Accreditation

Steps:

- 1. Once the program's self-study is approved and candidacy is granted, the program is assigned to a <u>Timetable to Initial Accreditation</u> subject to BOA visitor availability.
 - Examples:
 - Timetable to Initial Accreditation: October 2026
 - Timetable to Initial Accreditation: February 2027
 - Timetable to Initial Accreditation: June 2027
- 2. Initial Accreditation Visit Occurs
- 3. BOA Decision

Remember: obtaining candidacy status establishes the program's retroactive accreditation date and protects students, regardless of when the candidacy visit and BOA decision for initial accreditation occur.

Rationale

The Temporary Alternative Pathway was developed in recognition that practice doctorate programs have longstanding operational history and pilot participation was limited by design. Therefore, this pathway allows existing practice doctorate programs an expedited candidacy and initial accreditation option.



Eligibility

Temporary: pathway will only be open through July 2028


Eligibility:

- have secured all appropriate levels of approval and permissions to operate;
- > are fully operational; and
- have issued at least one (1) practice doctorate social work degree by August 1, 2025.

This is <u>not</u> a developmental process. Programs pursuing this pathway must be ready to <u>evidence full compliance with all standards</u>.

Pathway Caps

Traditional Pathway

- Cap of 10 baccalaureate, master's, or practice doctorate programs per agenda (no change in #)
- Visits conducted by current or recent trained BOA members
- Documents reviewed by current BOA members

Temporary Alternative Pathway

- No set cap based on visitor availability each cycle
- Visits conducted by current and recent trained BOA members
- Documents reviewed by Practice Doctorate Review Committee
- Goal: Move as many programs through the process as mindfully as possible according to visitor availability

Retroactive Accreditation & Student Protection

Traditional Pathway

 Obtaining candidacy status establishes the program's retroactive accreditation date and protects students.

Temporary Alternative Pathway

 Obtaining candidacy status establishes the program's retroactive accreditation date and protects students, regardless of when the CV3 occurs.



Practice Doctorate Review Committee Applicable to temporary alternative pathway Benchmark 3/Initial Accreditation decisions only.

- A Practice Doctorate Review Committee will be established between 2026-2029 to serve as readers and provide decision recommendations for BOA's consideration.
- Similar model: <u>CSWE Fellowship Review Committee</u>
- The BOA may accept recommendations made by the Practice Doctorate Review Committee or it may choose to take alternative actions. The BOA has sole and complete authority as the final arbiter of compliance.

Practice Doctorate Review Committee


- Members will be comprised of:
 - 6 former/recent BOA members, with specialized training and extensive experience conducting compliance reviews.
 - 1-2 current BOA members to serve as liaisons to committee and serve as a committee chair.
- •Rationale for this model: To temporarily increase BOA's review capacity during the initial influx of practice doctorate program accreditation applications, allowing more programs an expedited review.





Memo to the Social Work Profession Regarding Practice Doctorate Program Accreditation

March 31, 2025

Dear social work colleagues, clients, constituents, and public interests,

In social work education, the Council on Social Work Education's (CSWE) Board of Accreditation (BOA) is <u>recognized</u> by the Council on Higher Education Accreditation (CHEA) to accredit baccalaureate and master's social work degree programs in the United States and its territories. Since its inception in July 1952 (and its predecessor since 1919), CSWE has accredited master's programs. In 1974, CSWE began accrediting baccalaureate programs.

In recent years, the number of practice doctorate programs has grown from 5 in 2014 to 38 in 2024, and continues to grow according to a recent audit of social work programs conducted by CSWE. In response to questions regarding how practice doctorate degrees align within the social work education continuum, CSWE partnered with social work programs, social work educators and leaders, doctoral students, health accreditors, and other constituents to conduct an environmental scan, gather data and feedback, and create pilot accreditation standards prior to launching the accreditation pilot. prior to launching the accreditation pilot.





FAQs (so far...)

- 1. When can our program apply for accreditation?
 - August 1, 2025 or thereafter
- 2. Can I call our BSW/MSW accreditation specialist to discuss DSW accreditation?
 - No, please email Kat at <u>kgibson@cswe.org</u> with any questions.
 - At this time, consultation services are not available while the team works diligently on designing and launching critical application materials.
 - Additional templates, training, and services are forthcoming!



FAQs (so far...)

- 3. Is the program director credentials standard waiver-eligible?
 - Waiver-eligible standards are currently under discussion.
 - The BOA will make decisions/update the waiver policy after its June 4-7, 2025 meeting.
 - This standard is under compassionate consideration since accreditation is "meeting the market" and all recognize program directors are currently employed at DSW programs with a range of doctoral degrees.
- 4. For the Temporary Alternative Pathway, is a full selfstudy due with the application?
 - Yes, because programs seeking this pathway move from candidacy to initial accreditation within 1-year by demonstrating compliance with all standards.

FAQs (so far...)

5. Are sample DSW self-studies available?

- No, per policy and question #36 in our <u>general</u>
 accreditation FAQs accreditation staff do not share
 program-specific information with other programs for any
 purpose.
- Providing samples is <u>not</u> a common nor advisable practice amongst accreditors as programs are encouraged to implement and document compliance with the EPAS creatively according to their program's unique context. This allows for innovation, experimentation, and continuous quality improvement to thrive.
