

# **Proposal Categories**

Peer-Reviewed Proposals (Four Presentation Formats)

Each peer-reviewed proposal is submitted to one of the 39 Tracks. There are four presentation format options:

- 1. <u>Electronic Poster</u> (30 minutes, up to two presenters)
- 2. <u>Interactive Workshop</u> (60 minutes, up to five presenters)
- 3. <u>Paper Presentation</u> (30-minutes; up to two presenters)
- 4. Panel (60 minutes, up to five presenters)

Those submitting proposals must select only one presentation format per proposal.

Title: 14 words (max.)

Overview: 50 words (max.)

Proposal text: 500 words (max.)

Conclusions

• References: 500 words (max.)

Proposals will be reviewed for the following:

- Relevance of topic, study, or inquiry to CSWE members and conference theme
- Clarity of the written proposal or focus of inquiry
- Appropriateness of research method(s) and/or conceptual foundation
- Robustness of analytical and/or theoretical frame
- Significance for social work education, practice, research, policy, or theory
- Implications for antiracist social work education

# **Interactive Workshop**

Each workshop should include a highly interactive portion (i.e., breakout groups, exercises, and similar activities that engage the audience). Proposal components:

- Proposal text: 500 words (max., including citations)
  - o Background/Rationale
  - o References: 500 words (max.)
- Learning objectives (up to three, up to 50 words each; at least one objective is required): Indicate the learning outcomes participants will achieve by attending the workshop.
- Teaching methods: Describe how you will achieve the objectives in an interactive manner.

Proposals will be reviewed for the following:

- Relevance of topic, study, or inquiry to CSWE members and conference theme
- Clarity of the written proposal or focus of inquiry
- Appropriateness of research method(s) and/or conceptual foundation
- Robustness of analytical and/or theoretical frame
- Significance for social work education, practice, research, policy, or theory
- Implications for antiracist social work education

# **Paper Presentation**

Paper presentations (30-minute paper presentations; up to two presenters). Papers are lecture-format presentations that are paired under a common theme and are scheduled usually back-to-back in one-hour sessions.

### Proposal components:

- Title: 14 words (max.)
- Overview: 50 words (max.)
- Learning objectives: up to three, up to 50 words each. At least one objective is required.
- Proposal text: 500 words (max., including citations)
  - Background/Rationale
  - Methods/Methodology
  - Results
  - Conclusions
- References: 500 words (max.)

Proposals will be reviewed for the following:

- Relevance of topic, study, or inquiry to CSWE members and conference theme
- Clarity of the written proposal or focus of inquiry
- Appropriateness of research method(s) and/or conceptual foundation
- Robustness of analytical and/or theoretical frame
- Significance for social work education, practice, research, policy, or theory
- Implications for antiracist social work education

#### **Panel**

Panels (60 minutes, minimum of two presenters and up to five presenters)

Panel discussions are collaborative presentations on a single research topic, with two to five panelists.

Proposal components are to include the following:

- Title: 14 words (max.)
- Overview: 50 words (max.)
- Learning objectives (up to three, up to 50 words each; at least one objective is required): Indicate the learning outcomes participants will achieve while attending the workshop.
- Proposal text: 500 words (max., including citations)
  - o Background/Rationale
  - Objectives
  - Implications
- References: 500 words (max.)

Proposals will be reviewed for the following:

- Relevance of topic, study, or inquiry to CSWE members and conference theme
- Clarity of the written proposal or focus of inquiry
- Appropriateness of research method(s) and/or conceptual foundation
- Robustness of analytical and/or theoretical frame
- Significance for social work education, practice, research, policy, or theory
- Implications for antiracist social work education

# **Invited Proposals**

There are seven format options for invited proposals: three types of preconference workshops, one postconference institute, CSWE Connect sessions, Hot Topic sessions, and Partnership presentations.

#### Preconference Workshops

Three day-long preconference workshops will be presented on October 26, 2023. Each workshop is broken up into 1.5-hour sessions.

- Field Education Institute (Oct. 26)
- Teaching Institute (Oct. 26)
- Leadership Development Institute (Oct. 26)

# Postconference Institute

Assessment Institute (Oct. 29)

The 2023 APM will offer the Assessment Institute, on October 29, 2023, designed for faculty and academic staff members focused on assessment requirements of the 2022 Educational Policy and Accreditation Standards (EPAS). Sessions will be presented in 1.5-hour workshops. We seek proposals that address the assessment of anti-racism, diversity, equity, and inclusion in the curriculum, administrative and governance structures, and faculty and student recruitment and retention. We are particularly interested in anti-oppressive models of assessment.

# Non-Peer Reviewed Proposal Options

The following presentation formats are available for sessions Friday–Sunday, October 27–29, 2023.

- **CSWE Connect** (60 minutes, up to seven presenters)
- **Hot Topic** (20 minutes, one presenter)
- Partnership Presentations (60 minutes, up to 10 presenters)

Although invited proposals are not peer reviewed, they must follow the same procedures as peer-reviewed proposals.

Invited session proposals are reviewed by CSWE based on the following criteria:

- Relevance of topic, study, or inquiry to CSWE members and the conference theme
- Clarity of the written proposal
- Significance for social work education, practice, research, policy, or theory
- Implications for racial, economic, and environmental justice

Invited session proposals must provide

- learning objectives that use verbs such as "describe," "apply," and "evaluate" and methods that support skill building for social work faculty members and/or administrators, and
- sufficient information in the biography of each presenter to summarize the expertise of the presenter in relation to the invited proposal.

CSWE makes the final decision on all invited sessions based on the above criteria.

All session presenters are subject to the 2023 APM Presenter Agreement.

# **CSWE Connect**

CSWE Connect (60 minutes, up to seven presenters): CSWE commissions and councils are invited to submit proposals that highlight work that advances their charges and the mission of CSWE. Proposals should showcase any current projects and/or work being done. Priority will be given to proposals that relate to the theme of the conference. This option is only for CSWE commissions and councils.

• Title: 14 words (max.)

• List of presenters

Overview: 50 words (max.)Proposal text: 500 words (max.)

Invited session presenters are subject to the 2023 APM Presenter Agreement.

# **Hot Topic**

Presentations will consider emerging and important topics for social work educators or topics related to the conference theme but not covered by other APM presentations. Hot Topics will be TEDx-style talks and will be grouped with related Hot Topic sessions as part of a 1-hour session.

# Hot Topic Requirements:

• Title: 14 words (max.)

• Overview: 50 words (max.)

Topic focus area

• List of presenters

• Proposal text: 500 words (max.)

# **Partnership Presentations**

Partnership presentations provide opportunities for social work education-related groups to make special presentations at the APM.

- Presentations may be up to 60 minutes long with up to 10 presenters.
- Due to meeting space availability, each group will be limited to one accepted presentation.
- The leadership of each organization may select and invite the presenters.
- Held during the regular session hours.

## Partnership Proposal Requirements

• Title: 14 words (max.)

• List of presenters

• Overview: 50 words (max.)

Proposal text: 500 words (max.)

Invited session presenters are subject to the 2023 APM Presenter Agreement.

# **Proposal Structure**

Proposals will include a title, overview, proposal, references, and learning objectives. You will be able to copy and paste this information from another document.

Text limits for these proposal components are as follows:

• Title: 14 words maximum

Overview: 50 words maximum

• Learning objectives: up to three, up to 50 words each; at least one objective required

• Proposal text: 500 words (max.), including citations

• References: 500 words (do not submit bibliographies within proposal text)
