Explicit Curriculum

The explicit curriculum is the program's design and delivery of formal education to students, and it includes the curriculum design, courses, course content, and required academic product(s) for each of its program options. Using a practitioner-scholar perspective, the explicit curriculum prepares students for professional social work practice within an area of focus at the practice doctorate level. The curriculum prepares students for substantive expertise beyond the master's level in one or more areas of social work practice. The program defines its students' academic product(s) and selects the format that best incorporates the requirements of the area(s) of focus and the institution that is awarding the degree. The academic product(s) demonstrates students' core expertise and skills and contributes to the advancement of practice.

Explicit Curriculum

- Example opportunities for students to advance practice:

 - Preceptorships or residencies

Explicit Curriculum: Advancing Practice

- Can be woven into educational process, including:
 - Supervision/mentorship of an applied product/project
 - Capstone or other academic product course(s)
 - Series of courses to design, develop, and implement a project
 - Leadership seminar(s)

Explicit Curriculum: Professional Practice Communities Engagement

- **Compliance Statement f:** For each area of focus, the program describes how its curriculum is informed by professional practice community.

Explicit Curriculum: Professional Practice Communities Engagement

- Examples of mechanisms:
 - Design thinking exercises
 - Strategic planning processes
 - Engage more seasoned students in curriculum feedback, development, or design activities
 - Student liaisons in curriculum-focused faculty meetings
 - Reserving seats/positions on curriculum committee
 - Convening a community advisory board
 - Collecting feedback via surveys or focus groups
 - Annual review of syllabi to ensure use of current practice-based materials
 - Hosting guest speakers/panels

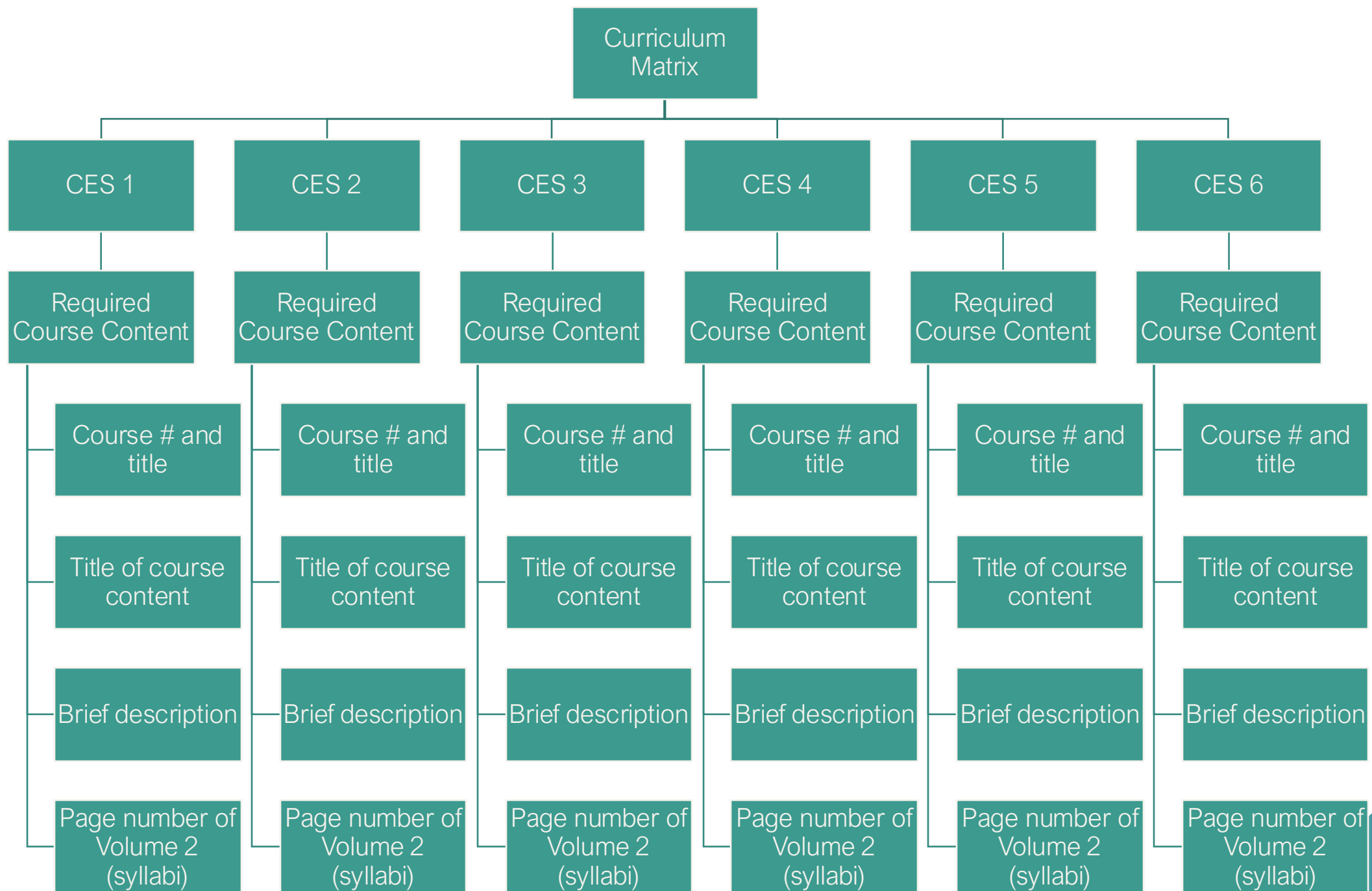

 - How does this ensure students' demonstrate a practitioner-scholar perspective?
